## CBEC Dog Membership Rules and Regulations



Due to the unique nature of CBEC's wildlife sanctuary, established guidelines for pet access will help us maintain the integrity and safety of our wildlife habitats, while providing an enjoyable outdoors experience for dogs and their owners.

**For the safety of our visitors, students, canine guests, and resident wildlife, we request strict adherence to the following rules and regulations:**

- Pets six months or older with current membership and vaccinations are welcome during weekends throughout the year.
- **Check-in for pets will take place at the** CBEC visitor center immediately upon each arrival.
- All CBEC pet members must visibly display a CBEC pet membership ID tag on collar.
- All dogs must be healthy, currently vaccinated, and collared with identification. (Proof of vaccinations to be submitted with membership form.)
- CBEC canine members must be leashed and under control by their owners/handlers at all times on trails and near buildings.
- Dogs are allowed off leash only at the designated beach area; however, pets must be on leash upon entering/exiting the boardwalk. (To ensure safety and enjoyment for all, owners/handlers must maintain control of their pets, whether on leash or off.)
- Pets are welcome at CBEC's picnic pavilions.
- We regret that dogs are not allowed inside the visitor center, education facilities, or within 10 feet of birds of prey exhibits.
- Pet sanitary stations are provided for your convenience. Owners/handlers must immediately clean up after their dog(s) and properly dispose of waste in designated receptacles to ensure a sanitary environment for our human and canine guests.
- Dogs in heat, or puppies under six months of age, are not allowed on the CBEC grounds.
- Pets may accompany owners/handlers on kayaks or canoes, at the owner's risk. In the interest of safety for all, CBEC suggests lifejackets for our canine "boaters."

*Please note:*

- CBEC is not responsible for injuries to dogs, their owners/handlers, or other visitors of the facility.
- Please report any problems, or abuse of rules, to CBEC visitor center or office to help us maintain a safe and enjoyable environment for all.
- We regret that any dog receiving a total of three violations will no longer be allowed at CBEC.
